1. WHAT INFORMATION DO WE COLLECT?

We collect personal information that you provide to us when you visit our website, request information about our products and Services, participate in activities on our Services, log into your account, schedule a demonstration of our products and Services, contact us from time to time, or otherwise voluntarily provide personal information to us through our website. We may collect personal information from third parties that provide contact discovery services, such as data and list brokers, to assist us in finding prospective business customers and verifying business contact information.

The information we collect may include personal information such as your name, email address, telephone number, username and password, and employment-related information, including but not limited to your company name and job title. We may also collect personal information from you automatically when you visit our website. This information may include your Internet Protocol (IP) address, your device and browser type, location data, information about your interactions with our website and advertisements.

2. HOW DO WE PROCESS YOUR INFORMATION?

We use your personal information to provide and administer our Services, provide you with the information you request about our products and Services, communicate with you from time to time, provide customer support, and provide advertisements, marketing promotions and offers about our products and Services we think may be of interest to you.

We also use your personal information about your use of our website and Services to monitor and improve our website and Services, for internal business analysis; for security purposes; to prevent fraud, activities that violate our Terms of Use or that are illegal; to protect our rights and the rights and safety of our users or others; and to comply with any of our legal obligations.

3. WHAT LEGAL BASES DO WE RELY ON TO PROCESS YOUR INFORMATION?

If you are located in Canada, this section applies to you.

We may process your information if you have given us specific permission (i.e., express consent) to use your personal information for a specific purpose, or in situations where your permission can be inferred (i.e., implied consent). You can withdraw your consent at any time. Click here to learn more.

In some exceptional cases, we may be legally permitted under applicable law to process your information without your consent, including, for example:

- If collection is clearly in the interests of an individual and consent cannot be obtained in a timely way
- For investigations and fraud detection and prevention
- For business transactions provided certain conditions are met

- If it is contained in a witness statement and the collection is necessary to assess, process, or settle an insurance claim
- For identifying injured, ill, or deceased persons and communicating with next of kin
- If we have reasonable grounds to believe an individual has been, is, or may be victim of financial abuse
- If it is reasonable to expect collection and use with consent would compromise the availability or the accuracy of the information and the collection is reasonable for purposes related to investigating a breach of an agreement or a contravention of the laws of Canada or a province
- If disclosure is required to comply with a subpoena, warrant, court order, or rules of the court relating to the production of records
- If it was produced by an individual in the course of their employment, business, or profession and the collection is consistent with the purposes for which the information was produced
- If the collection is solely for journalistic, artistic, or literary purposes
- If the information is publicly available and is specified by the regulations

4. WHEN AND WITH WHOM DO WE SHARE YOUR PERSONAL INFORMATION?

We may share your personal information with service providers that help us operate our business, including through payment processing, verifying customer information, managing customer information and providing customer service, facilitating scheduling and email communications, providing security services and cloud-based data storage, hosting our website and assistance with other IT-related functions, providing analytics information, legal and accounting services, among other business functions.

We may also share your personal information as required or permitted by law to comply with a subpoena or similar legal process or government request, or when we believe in good faith that disclosure is legally required or otherwise necessary to protect our or others' rights, property or safety, including to law enforcement agencies, and judicial and regulatory authorities. We may also share your personal information with third parties to help detect and protect against fraud or data security vulnerabilities. And we may transfer your personal information to a third party in connection with, or during negotiations of, any merger, sale of company assets, financing, or acquisition of all or a portion of our business to another company.

5. HOW LONG DO WE KEEP YOUR INFORMATION?

We will only keep your personal information for as long as it is necessary for the purposes set out in this privacy notice, unless a longer retention period is required or permitted by law (such as tax, accounting, or other legal requirements).

6. COOKIES AND ANALYTICS

Cookies are small, sometimes encrypted text files that are stored on computer hard drives by websites that you visit. They are used to help users navigate websites efficiently as well as to provide information to the owner of the websites. 7. HOW DO WE KEEP YOUR INFORMATION SAFE?

We have implemented and maintained appropriate and reasonable technical and organizational security measures designed to protect the security, confidentiality, availability, and integrity of any personal information we process. However, despite our safeguards and efforts to secure your information, no electronic transmission over the Internet or information storage technology can be guaranteed to be 100% secure, and data security incidents and/or breaches can occur due to a variety of factors that cannot reasonably be prevented; therefore, our security measures may not always be adequate to prevent all breaches of security.

8. DO WE COLLECT INFORMATION FROM MINORS?

Our Services are not directed to minors under the age of 18 and we do not knowingly solicit personal information from or market to children under 18. By using the Services, you represent that you are at least 18 or that you are the parent or guardian of such a minor and consent to such minor dependent's use of the Services. If we learn that we have collected personal information from minors under the age of 18, we will deactivate the account and take reasonable measures to promptly delete such data from our records. 9. WHAT ARE YOUR PRIVACY RIGHTS?
